ORDER

Whereas the Govt. of Odisha vide R&DM (DM) Deptt. Notification No. 1706/ R&DM (DM), dated 13.03.2020 has declared COVID-19 as a "Disaster" under section 2 (d) of the Disaster Management Act, 2005 for the state of Odisha and promulgated Odisha COVID-19, Regulation 2020 by virtue of the power conferred under section 2, 3 and 4 of Epidemic Disease Act, 1897 for containment of COVID-19.

And whereas, the National Disaster Management Authority, Govt. of India in exercise of Powers conferred u/s 6(2) (i) of the Disaster Management Act 2005 has directed the State Govt./ State Authorities to take measures for ensuring social distancing so as to prevent the spread of COVID-19 and directed the national Executive Committee under the said act to issue necessary guidelines in this regard.

Whereas in larger Public interest and with a view to contain the spread of COVID-19 and contact tracing for the identified case, I, Dr. Gavali Parag Harshad, IAS, Collector and District Magistrate-cum-Empowered Officer, after detection of one(01) no. of COVID-19 positive case belonging to under mentioned area, declare the **Tarapur village of Tarapur GP** under Dharamgarh Block as **Containment Zone** (Sketch Map enclosed) and the adjoining village of Karlakot (hamlet of Jharkundamal village) as **Buffer Zone** with immediate effect with following conditions:

- All Vehicular movement, movement of public transport and personnel movement will be stopped barring extremely urgent medical cases with the permission of undersigned in the containment zone.
- All inhabitants within the **Containment Zone** shall strictly remain in home. All the shopping establishments of whatsoever nature shall be closed immediately.
- All the Government and Private institutions located within the boundary of the **Containment Zone** are hereby closed forthwith.
- The movement of people in **Buffer Zone** is restricted except for essential works and strictly following the social distancing norms.
- Superintendent of Police, Kalahandi will make necessary arrangements for immediate deployment of adequate Police at required Points.

P.T.O.

- Sub-Collector, Dharamgarh will remain in overall charge.
- Tahasildar, Dharamgarh will be responsible for maintaining law & order.
- BDO, Dharamgarh will ensure supply of essential goods and Medical supplies in the Containment and buffer zone.
- CDMO, Kalahandi will ensure Contact tracing, IEC, active surveillance in Containment zone and passive surveillance in buffer zone.
- Other instructions as mentioned vide Order No. 2800/ R&DM (DM), Dated. 18.05.2020 Clause-5 will be applicable *mutatis mutandis*.
- The shutdown period is effective till **Midnight of 12th October, 2020.**



