ORDER

Whereas the Govt. of Odisha vide R&DM (DM) Deptt. Notification No. 1706/ R&DM (DM), dated 13.03.2020 has declared COVID-19 as a "Disaster" under section 2 (d) of the Disaster Management Act, 2005 for the state of Odisha and promulgated Odisha COVID-19, Regulation 2020 by virtue of the power conferred under section 2, 3 and 4 of Epidemic Disease Act, 1897 for containment of COVID-19.

And whereas, the National Disaster Management Authority, Govt. of India in exercise of Powers conferred u/s 6(2) (i) of the Disaster Management Act 2005 has directed the State Govt./ State Authorities to take measures for ensuring social distancing so as to prevent the spread of COVID-19 and directed the national Executive Committee under the said act to issue necessary guidelines in this regard.

Whereas in larger public interest and with a view to contain the spread of COVID-19 and contact tracing for the identified case, I, Dr. Gavali Parag Harshad, IAS, Collector and District Magistrate -cum- Empowered Officer, after detection of some COVID-19 positive cases belonging to under mentioned area, declare the following villages of **Sargiguda, Ghodabandh & Santpur** G.Ps under Narla Block as **Containment Zone** (Sketch Map enclosed) and the adjacent villages mentioned below as **Buffer Zone** with immediate effect with following conditions:

Sl. No.	Name of the G.P	Containment Zone	Buffer Zone
1	Sargiguda	Sargiguda (Ward No.04), Near Chari Chowk)	Within 3 k.m radius of containment zone
2	Ghodabandh	Bramhani	Within 3 k.m radius of containment zone
3	Santpur	Sanchiching	Within 3 k.m radius of containment zone

- All Vehicular movement, movement of public transport and personnel movement will be stopped barring extremely urgent medical cases with the permission of undersigned in the containment zone.
- All inhabitants within the **Containment Zone** shall strictly remain in home. All the shopping establishments of whatsoever nature shall be closed immediately.
- All the Government and Private institutions located within the boundary of the **Containment Zone** are hereby closed forthwith.

(P.T.O)

- The movement of people in **Buffer Zone** is restricted except for essential works and strictly following the social distancing norms.
- Superintendent of Police, Kalahandi will make necessary arrangement for immediate deployment of adequate Police at required Points.
- Sub-Collector, Bhawanipatna will remain in overall charge.
- Tahasildar, Narla will be responsible for maintaining law & order.
- BDO, Narla will ensure supply of essential goods & Medical supplies in the Containment and buffer zone.
- CDMO, Kalahandi will ensure Contact tracing, IEC, active surveillance in Containment zone and passive surveillance in buffer zone.
- Other instructions as mentioned vide Order No. 2800/R&DM (DM) Dated 18.05.2020 Clause-5 will be applicable mutatis mutandis.
- The shutdown period is effective till **Midnight of 30th September, 2020.**




CONTAINMENT ZONE AT SARGIGUDA (WARD NO. 04) NEAR CHARI CHOWK OF
