**ORDER**

Whereas the Govt. of Odisha vide R&DM (DM) Deptt. Notification No. 1706/ R&DM (DM), dated 13.03.2020 has declared COVID-19 as a "Disaster" under section 2 (d) of the Disaster Management Act, 2005 for the state of Odisha and promulgated Odisha COVID-19, Regulation 2020 by virtue of the power conferred under section 2, 3 and 4 of Epidemic Disease Act, 1897 for containment of COVID-19.

And whereas, the National Disaster Management Authority, Govt. of India in exercise of Powers conferred u/s 6(2) (i) of the Disaster Management Act 2005 has directed the State Govt./ State Authorities to take measures for ensuring social distancing so as to prevent the spread of COVID-19 and directed the national Executive Committee under the said act to issue necessary guidelines in this regard.

And whereas, containment zone has been declared in respect of Rekhpur village of Narla block vide Order No. 977/ Res/ Covid-19 Cell, dated 25.07.2020 following a case detected in the said area till Midnight of 27.07.2020.

And whereas 02 (two) more positive cases of Covid-19 have been detected from the said containment zone and with a view to contain further spread of COVID-19 and contact tracing of the identified cases, I, Dr. Gavali Parag Harshad, IAS, Collector and District Magistrate-cum-Empowered Officer, hereby extended the order for containment zone as well as buffer zone till 11.08.2020 for the above area. All instructions issued earlier vide Letter No. 977/ Res./ Covid- 19 Cell, dated 25.07.2020 will remain in force till midnight of **11.08.2020**.


