### **Scope of Work: -**

Mission Shakti Group (MSG) shall take the responsibilities of management Smart Park at Bhawanipatna Municipality and shall engage of driver and helper for door to door garbage collection vehicle at Bhawanipatna Municipality.

### **The scope of the work include as follows**

1. Door to door collection of wet waste and dry waste.
2. Segregated waste should be dumped in the wealth centre.
3. Smooth movement of vehicle in their respective assigned ward.
4. Cleaning of vehicle in regular basis.
5. The vehicle should move under the guidance of Swachha sathis and Swachha supervisors.
6. The helper should reach each and every HH to collect segregated waste.
7. The MSG will pay to driver and helper in monthly basis.

### **Payment to MSG**

The Mission Shakti Group will be paid a fixed amount of Rs.20,000/- (Rupees Twenty Thousand) only per month towards engagement of driver and helper for door to door collection vehicle.

## Role of Municipality

1. Bhawanipatna Municipality will supply fuel to all vehicle.
2. The vehicle mechanical maintenance should be done by Municipality.

## Criteria for Evaluation:-

1. The Mission Shakti Group must be adhering to **Pancha Sutra** management.
2. The Mission Shakti Group must have been involved in Income Generation Activity (IGA) at least for 2 years.
3. The Mission Shakti Group must have an annual turnover of minimum 1 lakhs per annum for last 1 years consecutively.
4. The Mission Shakti Group must have not been involved in any financial irregularities such as loan declared as NPA, Pre-settlement or one time settlement of loan etc.
5. The Mission Shakti Group members should not have record of involvement in any anti-social activity.
6. The Mission Shakti Group having experience in similar kind of activities may be given preference.

## Submission of Expression of Interests.

The Mission Shakti Group shall submit their EOI as per the formats in Annexure-I & II along with photocopies of all the supporting document and should be covered with Seal and details of SHG with Phone No. And clearly super scribed as "EOI for Selection of Mission Shakti Groups for engagement of Driver and Helper for door to door (garbage) collection vehicle under Bhawanipatna Municipality. EOI on its complete form in all respect as specified must be submitted on or before 25.11.2022 at Bhawanipatna Municipality addressed to the Executive Officer, Bhawanipatna Municipality. Address: Bhawanipatna Municipality through speed post/ registered post/ Courier or by Hand. The EOI will be opened on 28/11/22 at 11:00: P.M / AM. in the presence of the bidder, who wish to attend.

## Term & Condition

1. An agreement will be executed between the ULB and selected MSG for a period of **one year** from the date of execution of agreement and may be renewed for further period thereafter on mutual agreement of the parties and basing on the satisfactory performance report of supervision committee on engagement of

Driver and Helper for door to door (garbage) collection vehicle. If the Mission Shakti Group fails to perform their duty, the Bhawanipatna Municipality may terminate the agreement in the interest of discharge entire responsibility.

2. The Mission Shakti Group shall pay the remuneration to the human resource engaged by them in time.
3. The Mission Shakti Group will bear the expenditure incurred towards engagement of one driver and one helper engaged by them.
4. The Mission Shakti Group will be paid a fixed amount of Rs.24, 000/- (Rupees Twenty Four Thousand) only per month towards payment to the driver and helper.
5. The Mission Shakti Group will deploy their driver and helper from 6.00 A.M to 12.00 P.M and 4.00 P.M to 06.00 P.M.
6. The question of violation or breach of any of the conditions by any Party or any dispute arising between the parties it would be decided by the Executive officer and Chairperson.
