As per Bye-Law of District Council of Culture (DCC), in every 03 (Three) years the membership of DCC should be changed. But the DCC, Kalahandi has not been reconstituted since 1995. In this connection, the interested candidates can apply for the post of DCC member having the following criteria as per the Bye-Law which are detailed below.

CRITERIA FOR MEMBERSHIP

- 01) National Awardees belong from Kendra Sahitya Academy / Kendra Sangeet Natak Academy / Kendra Lalit Kala Academy. (Strength- 03 (Three) numbers).
- 02) State Awardees belong from Odisha Sahitya Academy / Odisha Sangeet Natak Academy / Odisha Lalit Kala Academy. (Strength- 03 (Three) numbers).
- 03) Creative Artist and Experts from the District (As members of the Odisha Sahitya Academy / Odisha Sangeet Natak Academy / Odisha Lalit Kala Academy).
- 04) Representatives of National / State / District Level Voluntary Organizations which have executed any programme or scheme within the District. (Strength- 06 (Six) numbers).
- 05) Cultural Co-ordinator (An Official or Non-Official person having expertise and experience in organizing /co-ordinating cultural programmes).
- 06) Special Invitees (Selected by the Collector & Chairman, DCC when necessitated by specific occasions).

The interested candidates should submit the application along with required documents to the Collector & Chairman, DCC, Kalahandi through the DCO & Secretary, DCC, Kalahandi on or before Dt. 22.06.2022 positively. The applications will not be received after due date. The selection procedure of membership of DCC will be decided in DCC meeting. The date, time & venue of DCC meeting will be intimated later on.
