Whereas, consequent upon further verification of the GRS computerised provisional list with the original documents received from the applicants for recruitment to fill up 66 (sixty six) numbers of Gram Rozgar Sevak (GRS) under MGNREGS, by the teams constituted for the purpose vide Office Order No. 1041 dtd. 22.3.22 of the DRDA, Kalahandi, 06 (six) numbers of ineligible applications have been detected in addition to 159 numbers of applications found ineligible earlier.
