The Tender Committee Meeting was held on 29.12.2020 at 11.00 A.M under the Chairmanship of the Sri Biranchi Narayan Darwan, OAS – I (SB), Project Administrator, ITDA, Th. Rampur, Bhawanipatna at the conference hall ITDA for opening of Tender paper for engagement of Technical Consultant. At the outset, the Chairman welcomed the participant members and connoted the aim and objective of the meeting and details of the tender process.

In adherence to the publication of the tender call notice on dated 05.12.2020 in the Odia daily newspaper i.e. The Samaj / The Odisha Vaskar and daily English newspaper the Indian Express through DIPRO, Kalahandi. The same was also uploaded in the District website i.e. www.kalahandi.nic.in vide this office Tender Call Notice No. 1576 dated 03.12.2020 and invited the suitable agencies for selection of Technical Consultant (Service Providing Agency). The tender (Technical Bid) was opened on 29.12.2020 at 11.00 AM in the conference Hall of ITDA, Th. Rampur, Bhawanipatna.

13 nos. of tender papers were received. Out of 13 tender papers 3 tender papers received after due date (i.e. 22.12.2021 at 05 P.M). The Tender Committee not considered the 03 nos. of Agency namely 1. Active Security and Intelligence Services, 2. Wrestler Security Service & 3. Mind Mart for opening of Technical Bid. Rest 10 nos. of tender documents were scrutinized thoroughly and the details observation and findings of each case are noted below:-

Findings:-

Out of 10 nos. Agencies 08 Agencies submitted all the statutory and mandatory documents and qualified for Technical Bid. Remaining 02 Agencies namely 1.Rajesh Enterprises, Bhawanipatna and 2. M/S- Santoshi Infotech, Nabarangapur were not qualifying in the technical bid in due to non-compliance of some mandatory documents as per the tender paper invited.

1. The **Rajesh Enterprises** has submitted the both statutory and mandatory documents but he has not submitted to similar experience proof in the tender paper. Hence the committee not considered its candidature for qualifying in the Technical Bid.
2. The **M/S Santoshi Infotech** has submitted the both statutory and mandatory documents but he has not submitted the requisite Registration Certificate. The certificates submitted in the tender paper regarding Registration proof, the representative of said Agency not clarified before the committee and renderers of the Registration certificate. Hence the Committee not considered M/S Santoshi Infotech for qualifying of Technical Bid.



Recommendation:- The Tender Committee unanimously decided to open the Financial Bid of qualified 08 nos. agencies as above.


