Sealed tenders in plain papers are invited from the intending participants having license under Orissa Mineral (Prevention of Theft, Smuggling & Illegal Mining and Regulation of Possession, Storage, Trading and Transportation) Rules-2007 dealing for dispose the seized and confiscated **Quartz** as mentioned below lying at different places will be put into public auction on "**As is where is basis**". Sealed tenders quoted with offer price will be received in this office by the undersign at 3.00 PM on Dt. **12.10.2023** and will be opened at 4.00 P.M. in presence of all the bidders or their authorised representatives. The tender papers should accompany with E.M.D. mentioned below in shape of Demand Draft Payable at any Nationalized Bank in favour of the Deputy Director of Mines, Kalahandi Circle, Bhawanipatna along with copy of license for Quartz granted under OM(PTS&IMRPSTT) Rules,2007 failing which the tender application shall not be considered. The E.M.D. of successful bidder shall be adjusted against the bid value and the others will be refunded. The highest bidder whose tender will be accepted shall have to deposit at least 25% of the offered amount immediately after the tender is confirmed or else the tender shall be treated as **null and void** and the E.M.D. shall be forfeited to Government. The balance amount should be deposited within 7 days from the date of acceptance of tender failing which 25% of the offered amount deposited earlier shall be forfeited to Government. The stock of Quartz under auction may be inspected by any respective participant during working hours of any working day with prior permission of the undersigned. The successful bidder should remove the quartz from the site within 30 days from the date of issue of lifting order under the provision of OM(PTS&IMRPSTT)Rules,2007 and amendment Rule, 2015. Since the disposal of quartz is being held "as is where is basis", the auctioning authority shall not have responsibility towards quality and quantity in case found shortage.
