QUOTATION CALL NOTICE

Sealed quotation are invited from interested reputed Travel Agency/ Tour Operator or private individual in the enclosed format for providing (1) one A.C / Non-A.C diesel driven 4 wheeler vehicle of Bolero type or any higher type having sitting capacity of not more than 10 (Ten) including driver which shall confirm to the terms and conditions given below for official use in Koksara Block on monthly rent basis for a period of 1 year. The maximum hire charge per month is Rs. 31000/- as prescribed by the Government.

1. The vehicle must be in road worthy condition and must not be more than 3 years old from the date on initial registration. It should have Valid Registration Certificate, Fitness Certificate, Valid Condition Carriage Permit Proof of up to date tax payment etc. which are mandatory for plying of vehicle.
2. The Driver of the vehicle must have a Valid Driving License for driving light transport vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The driver should well behaved gently and obedient in nature.
4. The monthly rate of hire charge be quoted separately in the general information (excluding fuel and lubricant but including remuneration to the driver).
5. Vehicle must achieve a fuel efficiency of 10 k.ms per liter.
6. The details of the make and year of manufacture of the vehicle registration number, mileage (kms covered per liter) and name of the Driver with Driving License No. and period of validity should be specifically be provided in the general bid information to be furnished with quotation .
7. The quotation must be accompanied with copies of relevant documents and an Account Payee Bank Draft of Rs.5000/- (Rupees Five Thousand only) drawn in favour of Block Development Officer, Koksara payable at Koksara as Security Deposit. The Bank Draft of unsuccessful bidder will be returned whereas the Bank Draft of successful bidder will be retained, which will be refunded after expiry of the period of contact. The quotation without copies of relevant document and Bank Draft of specified amount will be summarily rejected.
8. The quotation complete in all respect should reach the undersigned on or before 24.01.2024 up to 04:00 pm through registered post only. No other mode of submission of the quotation will be accepted. Quotations received after due date will not be accepted in any circumstances. The quotations received within the due date shall be opened on the same day at 05:00 p.m. in presence of the bidders or their authorized representatives who may like to present.
