Conditions

1. The suppliers shall have GST registration no. to participate / submit EOI for supplying of materials.
2. The supplier shall be registered in GeM platform.
3. The rate quoted in EOI will be valid for a period of one year after receipt of allotment.
4. The EOI should be supported with GSTIN certificate, Its number and relevant documents.
5. The rate should be quoted in the Financial Quotation format per unit / per piece inclusive of all taxes (SGST/ CGST) and deliver to this office.
6. The Authority reserve the right to approve or cancel any part / full of the EOI without assigning any reason thereof.
7. The required quantity of aforesaid equipment need to be supplied by the supplier within 15 days from the date of receipt of supply order for which the firm should be committed in the agreement.
8. The selected firm have to deposit security money amounting to Rs.5000 (rupees five thousand) only in the shape of Bank Draft drawn in favor of DAO, LFA, Kalahandi.
9. The firm whose EOI will be accepted shall have to execute an agreement with District Audit officer, Local Fund Audit, Kalahandi in non-judicial stamp paper with Rs.10 (Rupees Ten) only in the next date of receipt of supply order.


