2. The appointment order is purely temporary and shall be terminated at any time without assigning any reason thereof.
3. The appointee shall be abiding by the Odisha Civil Service Conduct Rules, 1959 and subsequent amendment thereof and Odisha Civil Service (Classification, Control and Appeal) Rule, 1962.
4. The Appointee shall affirm an oath of allegiance to the Constitution of India at the time of joining.
5. He shall be enrolled under the New Pension Scheme contained in the Odisha Civil Service (Pension Rules, 1992 from the date of his joining.
6. The appointee should report before the District Culture Officer, Kalahandi 26.03.2024, failing which the appointment will be automatically stand cancelled.
7. No. TA / DA is admissible to the appointee for joining.
8. The appointee shall produce / furnish the following documents at the time of joining:
 - (I) Medical Fitness Certificate of Health from Medical Officer not below the rank of Assistant Surgeon of Govt. Hospital
