Background:

Odisha Adarsha Vidyalaya Sangathan is a path breaking initiative of Govt. of Odisha to provide quality teaching in English medium at Secondary & Senior Secondary level for the children specially in semi- urban or rural areas and to give scope to rural talents who are unable to afford English medium education. Hence to provide a high quality education through English Medium School, Odisha Adarsha Vidyalaya, Masanimunda in Kesinga Block was established in the year 2016 by Odisha Adarsha Vidyalaya Sangathan, Nayapalli, Bhubaneswar under the Department of School & Mass Education, Govt. of Odisha.

Basically, Adarsha Vidyalayas will have infrastructure and facilities of the same standard in Kendriya Vidyalaya with stipulation on Pupil-Teacher ratio, ICT usages, holistic educational environment, appropriate curriculum and emphasis on output and outcome. The objective is to provide high quality English medium school to the rural as well as semi-urban talents.

Key features of Odisha Adarsha Vidyalaya:

- The objective is to provide high quality English medium school to the rural as well as semi-urban talents.
- Vidyalaya will have holistic and integral touching upon physical, aesthetic development in addition to academics.
- The Vidyalaya will have adequate ICT infrastructure and internet connectivity.
- There will be sufficient scope for sports and co-curricular activities.
- There is provision of Art, Music and Computer Teacher besides subject teachers.
- Special emphasis will be given on teaching of Science, Math and English.
- There is provision of well-equipped laboratories and library.
- Medium of instruction is English and the Vidyalaya is affiliated to CBSE, Delhi.
- The Vidyalaya will have appropriate pace setting activities, so that Vidyalaya in the neighborhood can benefit from it.
- The classes will be from VI to XII having two (02) sections in each class with intake capacity of 40 in each section.
- All efforts will be made to make it really a centre of excellence.

GUIDELINES FOR ADMISSION OF STUDENTS IN CLASS XI IN OAVs, 2024 -25

1. Intake Capacity

- a. Science – 80 (02 Sections with 40 Students)
- b. Commerce – 80 (02 Sections with 40 Students)

2. Subject Combination

a. Science

- i. Physics, Chemistry, Mathematics, Biology, English
- ii. Physical Education/ Painting/ Information Technology/ Artificial intelligence are to be offered as elective/ 6th optional subject following CBSE guideline and any other instruction issued by OAVS.

b. Commerce

- i. Elective Subjects – Accountancy, Business Studies, Economics, English
- ii. Optional Subjects - Painting, Physical Education (any 01 to be opted by student)

3. Minimum Eligibility

a. CLASS XI (SCIENCE)

- i. A student belonging to the **General/OBC/SEBC** must have secured **55% and above marks in aggregate** along with **minimum 50% marks in both Mathematics and Science (combined)** in Class X Board examination (CBSE or any other Board).
- ii. A student belonging to the **SC/ST** category must have secured **50% and above marks in aggregate** along with **minimum 45% marks in both Mathematics and Science (combined)** in Class X Board examination (CBSE or any other Board).

b. CLASS XI (COMMERCE)

- i. All students of OAVs as well as other than OAVs if declared successful (pass) in Class X Board examination (CBSE or any other Board).

4. A Student shall apply for admission in one stream only.

5. All notifications and circulars issued by CBSE shall be followed for subject combination in Class XI as per stipulated guidelines.

6. Order of preference for admission:

- a. Students of own OAV (Including students selected for ICONIC OAV)
- b. Students of other OAVs (of same district, not having Class XI) selected for Iconic OAV
- c. Students of other OAVs (of same district, not having Class XI)
- d. OAV students of other districts

- e. Students of Government/ Government aided High schools within the same block.
 - f. Students of private high schools within the same block.
 - g. Students of Government/ Government aided high schools of other blocks of the district.
 - h. Students of Private high schools of other blocks of the district.
 - i. Students of Government/ Government aided High schools of other district.
 - j. Students of private high schools of other district.
7. Student selected for ICONIC OAV, Bhubaneswar is eligible for taking admission in Science stream only.
 8. Merit list shall be prepared on the basis of merit i.e. the marks secured in Class X Board examination (CBSE or any other Board) as detailed in point 3 above.
 9. Principals are requested to prepare prospectus for admission in Class XI which may be supplied to the applicants for admission.
 10. All OAV Principals (having Class XI) can spend a maximum of Rs 3000/- towards popularisation of Class XI admission. Above amount to be met from Vidyalaya contingency.
 11. Schedule for admission shall be communicated to all by OAVS.
