The sealed quotation should reach the undersigned by 16.07.2024 as per the terms & conditions given below.

Terms & Conditions

1. Sealed Quotations should be completed in all respects and addressed to "The General Manager , District Industries Centre, Kalahandi, Bhawanipatna" , submitted on any working day during office hours in person or by post/courier which should reach this office by the scheduled date and time . The last date for receipt of sealed quotations through post/ in person by Office of the General Manager, District Industries Centre, Kalahandi , Bhawanipatna is 16.07.2024 up to 5.30 P.M.
2. The quotation received after due date and time & incomplete in any manner will be rejected . The General Manager ,District Industries Centre ,Kalahandi,Bhawanipatna will not be liable for postal delay if any.
3. If the last date of receipt quotation turns out to be a holiday , it will be automatically be extended to the next working day.
4. All the pages of the submitted documents should be signed by the Head of the Dealers/ Suppliers or the authorized representative on behalf of the dealers / suppliers along with seal of the firm and date.
5. The District Industries Centre , Kalahandi shall not be responsible for accidental opening of the covers that are not properly superscribed and sealed before the time notified for opening of quotations.
6. Submission of more than one competitive quotation by the same dealers/ suppliers in response to the Quotation call notice is prohibited. All such quotations except one received first will be cancelled at the discretion of the authority calling the quotation.
7. Copy of valid Registration Certificate issued by Competent Authorities under the GST Act and copy of the PAN shall be enclosed to the quotation document . In no case other certificates issued by authorities in lieu of such certificate shall be accepted.
8. The participant agencies should submit the company registration certificate/partnership deed or SSI Registration , etc. as applicable.
9. The firm should not be blacklisted anywhere and a self declaration should be provided along with the quotation.
10. Interested suppliers / dealers may visit this office located near Manikeswari Chowk , Bhawanipatna during office hours to find out the condition of old batteries, if required.

11. The rate quoted should be exclusive of taxes , etc. The tax components should be indicated separately with rate of tax.
12. The finalization of registered dealers / suppliers shall be based on the LI rate.
13. The warranty of the Batteries should be minimum of 3 years or more covered from the date of installation of Batteries.
14. No extra charges will be paid towards installation & transportation etc.
15. Payment shall be made after supply & receipt of materials found in good condition & in the mode of Electronic Fund Transfer (EFT) or e-payment or by cheque. The selected suppliers / dealers, should indicate EFT No. and other relevant details , Banker's name , address , type of a/c and a/c no and IFSC no. etc in their office bills. Selected dealers / suppliers are required to submit an authorization form duly for e-payment to them.
16. No claim for price increase will be entertained during the purchase period.


