

01. The tender schedule will be available in the kalahandi district website <http://www.kalahandi.odisha.gov.in> and ULB website <http://www.bhawanipatnamunicipality.in> from 09/07/2024 to 24/07/2024 upto 5.00 PM and same will be opened on 30/07/2024 at 11.00 AM in the office of the undersigned.
02. The tenderer should quoted the rate to be deposited clearly both in figures as well as in words. This amount is to be deposited at a time on shape of Demand Draft in favour of Executive Officer, Bhawanipatna Municipality payable at Bhawanipatna. No cash or personal cheque will be entertained in this regard.
03. The tender for Daily and Weekly market should be accompanied with 03 (three) months quoted value as security deposit.
04. The paper cost for Daily and Weekly Market is Rs 6,000/- , for Advertisement Hoarding is Rs 2,000/- and for Naktiguda Tank & Nuabandh Tank is Rs 400/- in shape of Demand Draft in favour of Executive Officer, Bhawanipatna Municipality payable at Bhawanipatna. 05. For Advertisement of hoarding and Nuabandh Tank & Naktiguda Tank property accompanied with quoted value as security deposit.
06. The Security deposit will be refunded to the un- successful tenderer within a period a period of one month of issue of order on request.
07. The successful tenderer has to execute an agreement with the undersigned within 07 (Seven) days from the date of issue of order. Failure to execute agreement within stipulated time of seven days, Second highest bidder will be considered for the said lease and in that case security deposit will be forfeited.
08. The bidders should submit separate tender paper for lease of each Municipal property.
09. The Agency should clear all the Municipal dues before apply for this lease failing which his case will not be entertained.
10. The agency will collect hoarding charges from all display board having size 12' x8' or above in respect of Advertisement Hoarding.
11. The Municipal tank should be utilized for the purpose of Pisciculture only and the pesticide should be utilized as approved by the Fishery Department, Kalahandi.
12. The lessee will deploy his manpower and money receipt what so ever required for collection of the above fees.
13. The rate of collection of market fees for Daily / Weekly Market @ Rs 10/- (Rupees Ten) only per trade.
14. There should not be any traffic congestion or inconvenient to public on the place of erection of Advertisement hoarding.
