The Superintending Engineer, Rural Works Division, Dharmagarh on behalf of the Governor of Odisha invites **Percentage Rate tenders for the Building works for 2024-25 through e-Procurement**. The bid should be submitted online in the website www.tendersorissa.gov.in by eligible class of contractors of Government of Odisha or of equivalent class of other State Government / Railways / CPWD / MES. The bidders should have the necessary Portal Enrolment (with his own Digital Signature Certificate). The registered bidders of outside Odisha can also participate in this process, after necessary Portal Enrolment, but shall have to subsequently undergo registration with appropriate authority of the State Government before award of the work.

And less than Rs.3.00 Crore
- d) Estimated cost up to Rs.40.00 lakh: **C Class**(of Odisha PWD) or relevant class of other licensing authorities
- e) Estimated cost less than Rs.20.00 lakh: **D Class** (of Odisha PWD) or relevant class of other licensing authorities.



- 9) The bid for work shall remain open for acceptance for period of 90(ninety) days from next day to the date of receipt of bids. If any Bidder/ Tender withdraws his bid/ tender before the said period or makes any modification in the terms and conditions of the bid, the said earnest money shall stand forfeited.
- 10) The successful bidder who has quoted less bid price/ rate than the estimated cost put to tender shall have to furnish the differential cost as tabulated below i.e., estimated cost put to tender minus quoted amount as additional performance security (APS) in the shape of DD / TDR/BG pledged in favour of Superintending Engineer,R.W.Division, Dharmagarh within 07(seven) Days from date of intimation otherwise the bid shall be cancelled & security deposit shall be forfeited. Further, proceeding of blacklisting shall be initiated against the bidder.






