
ORDER

Allotment of Rice received vide Letter No.6184, dt.07.04.2025, from the Govt. Food Supplies & Consumer Welfare Department, Odisha for the **1st half of 2025-26 i.e from April 2025 to September 2025** are to be distributed of quantity **22,384.8 qtls of Rice** among the **24,872** boarders of Welfare Institution & Hostel Scheme (Government Owned/Run) ST/SC & SME of Kalahandi District managed by ST & SC Development Deptt., Odisha & further quantity of **667.8 qtls of Rice** are to be distributed among the **742** boarders in Govt. Sponsored/Aided Welfare Institution / Hostels of Kalahandi District managed by SS & EPD / W & CD, Deptt., Odisha. The scale of entitlement is limited to 15 Kg per boarder per month. The Rice should be lifted from **RRC-cum-DSC** of concerned Block by the concerned Head Master/Head Mistress of the institutions .The issue price of the fortified rice for the Govt. Run/Owned Insitutions is Rs 1/- per kg and the issue price of fortified rice for Govt. Aided /Sponsored Institutions will be at the erstwhile BPL rates (@ Rs 5.65 paise per KG) ..

It is requested to issue fortified rice to the welfare institution/Hostels (Govt. Run/Own and Aided/Sponsored only) in this district .

1. There will be no diversion of rice from WI Scheme to ST/SC Hostel and vice versa.
2. The institutional Head is directed to deposit the cost well in advance and all other terms and condition remain unchanged.
3. The District Level Officers concerned of Department will certify utilization of stock for bonafide purpose in the end of every month.
4. The institutions will lift quota from the concerned Rice Receiving Centre-cum-Departmental Storage Centre .
5. All the District level officers of the concerened Administrative Departments is requested to adhere to the following lifting schedule without fail :

Allocation for April 2025	To be lifted by 3 rd May 2025
Allocation for May 2025	To be lifted by 3 rd May 2025
Allocation for June 2025	To be lifted by 31 st May 2025
Allocation for July 2025	To be lifted by 30 th June 2025
Allocation for August 2025	To be lifted by 31 st July 2025
Allocation for September 2025	To be lifted by 31 st August 2025
UC to be submitted to FS&CW Department/OSCSC	By 10 th September 2025
