NOTICE INVITING EXPRESSION OF INTEREST (EOI) FOR CONSULTANCY OF SOLAR COLD STORAGE IN REGULATED MARKET COMMITTEE JUNAGARH, DISTRICT OF KALAHANDI, ODISHA

REGULATED MARKET COMMITTEE of Kalahandi District under Odisha State Agricultural Marketing Board (OSAMB), for the regulation of buying and selling of agricultural products by assisting and associating with farmers & traders to establish an efficient marketing system, where the growers may obtain reasonable and competitive price and the traders receive a fair deal in trading. The objective is also to develop modern market yards, where scientific godowns for storage, platforms for auction of agricultural commodities, display yards, traders' shop, and facilities, are provided with.

The RMC Junagarh intends to invite bids (techno-financial Bid) from interested and technically qualified agencies under its solar cold storage initiative with required civil work. The purpose is to hire a consultancy for conducting technical study & tender management in close association / consultation with RMC as per the description of work stated below:

- 1) Site Survey and technical feasibility analysis.
- 2) Get suitable solar cold storage design solution for each site with technical, basic arrangement drawings and a market base price for system from Indian manufactures.
- 3) Prepare a report on each individual solar cold storage sites with time schedule and project completion plan.
- 4) Assist in preparation of tender document.
- 5) Assist in technical evaluation of tender
- 6) Assist in project implementation and monitor the technical of all sites.

- b) The price should be quoted Exclusive of GST. GST will be paid as per actual.
- c) The RMC shall not be responsible for any delay in postal services. It is responsibility of consultant for ensuring timely delivery the design and details for the project and sites.
- d) The engineering consultancy should have done at least 3 design & two installations of solar cold storage in last three years in the state RMCs. The team of engineering consultant should have one mechanical, one electrical and one computer science engineer and preferably from IITs/ IISc/ NITs/ NPTIs.
- e) Office in Odisha to visit the sites and prepare design drawing, assist in evaluation of construction companies offers and finalize the bid.
- f) Registered startup in Odisha will get the first preference.
- g) The bid should contain two parts one for Technical Bid and second for Financial Bid as provided.
- h) The bid must accompany with a non-refundable Bid-document processing charge of Rs. 2,000 (Rupees two thousand only) separately in the form of Demand Draft drawn in favor of Secretary, RMC Junagarh payable at Junagarh.
- i) The scope of work for the consultancy will be submitted with its time schedule to finish the project and also a write up for approaching the design and project implementation process.

1. 20% site survey and site preliminary report.
2. 50% on submission of technical and tender documents.
3. 20% after bid evaluation and project award
