Sub: Corrigendum regarding the tender call notice for hiring of vehicle vide letter no 2455 dated 11.04.2025.


This office tender call notice letter no 2455 dated 11.04.2025 regarding financial bid in Annexure-II.

(Maximum of Rs. 31,000/- instead of Rs. 26,271/- as quoted earlier)


