The registered bidders of outside Odisha can also participate in this process, after necessary Portal Enrolment, but shall have to subsequently undergo registration with appropriate authority of the State Government before award of the work.



Division, Dharmagarh within 07(seven) Days from date of intimation otherwise the bid shall be cancelled & security deposit shall be forfeited. Further, proceeding of blacklisting shall be initiated against the bidder.




