The quotation should be subscribed from "Quotation for providing vehicle on monthly hire basis" on the cover of the sealed quotation which will be received in the office of the C.D.P.O, Dharamgarh by 15.07.2025 up to 29.07.2025. The application form is available in the office of the C.D.P.O, Dharamgarh. The quotationer may get the application form in any working day up to 29.07.2025 between 10 A.M to 5.30 P.M. The Quotationer/ Tendered may drop the sealed quotation in the Tender box fixed in the office in any working day by 29.07.2025 Up to 5.30 P.M. the sealed quotations will be opened in presence of the quotationer/tenderers or their authorized agents on 31.07.25 at 11 A.M.

The undersigned reserves all the right to cancel the selection without assigning any reason thereof.

TERM & CONDITIONS

1. The service provider shall have a valid GST registration to participate in the tendering.
2. The vehicle must be in road worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, Pollution certificate, valid contract Carriage permit, proof up-to-date tax payment etc. mandatory for plying of vehicle.
3. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport/passenger vehicle.
4. The driver should be well behaved, gentle and obedient in nature.
5. A sum of Rs. 5000/- shall be deposited by the intending bidders in shape of Account payee bank draft drawn in favor of the I.C.D.S Dharamgarh and submitted along with the tender as EMD. After completion of tender process, EMD shall refund to unsuccessful bidders.
6. The monthly hire charge of the vehicle to be quoted separately in the general bid information (including fuel & lubricant).

7. Maximum hire charge of the vehicle will be Rs. 24,000/- (excluding fuel).
8. The vehicle must achieve a fuel efficiency of 10-12 km/liter.
9. The details of the make and year of manufacture of the vehicle, registration no., mileage (Km covered per liter) and name of the Driver, Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the Quotation/Tender (Appendix-II).


