
Sealed quotations are invited from interested registered Travel Agencies or Private Individual/ service provider for providing 1 No. of vehicle (AC vehicle) having sitting capacity not more than 5 including driver for engagement of vehicle to the District Labour Officer, Kalahandi, Bhawanipatna preferably for Kalahandi district on monthly rent basis i.e. maximum 24,000/- (Twenty-Four Thousand Only) excluding GST. The GST registration by the service provider/owner of the vehicle is mandatory. (Preference will be given to BS-VI compliant petrol vehicles). The application form along with terms and conditions for hiring/engagement of vehicles will be available in the office of the Divisional Labour Commissioner, Kalahandi, Bhawanipatna during the office hours of the working days on payment of Rs.100/- (Rupees One Hundred) only towards application fee (non-refundable) from 3.00 PM of dated 13.01.2026 to 3.00 P.M. of 19.01.2026.

The bidder quoted lowest rent than the maximum rent as mentioned in this notice will be considered as selected bidder.

A sum of Rs.5000/- shall be deposited by the intending bidders in the shape of Accounts Payee Bank Draft Drawn in favour of the "**District Labour Officer, Kalahandi**" and submitted along with the tender as EMD. After completion of tender process, EMD shall be refunded to unsuccessful bidders.







TERMS AND CONDITIONS FOR HIRING OF VEHICLES

The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly rent basis.

1. The hired vehicle, during period of contract, shall have all necessary valid MV documents such as:- valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up-to-date Tax payment etc. and D.L. of the Driver available all the times. The Department/Office hiring the vehicle shall not be responsible for any damage/ loss caused to hired vehicles or loss of life / injury made to any person or damage to any property on account of use of hired vehicle any manner whatsoever. The hirer shall be responsible for all such litigation.
2. The hired vehicle preferably from the same district i.e. Kalahandi district.
3. The hire charges to be paid for monthly basing is final but does not include fuel cost, which is to be paid separately as per existing Government norms. All the expenditure of the vehicle towards repair, replacement of spare parts, lubricating oil of Engine, Gear Box & differential Coolant, Tyre & Tubes, Battery etc. will be borne by the bidder.
4. It shall be the responsibility of the bidder to provide a licensed, good driver (gentle, well behaved, obedient and non-alcoholic) and salary of the driver shall be borne by the owner.
5. The Vehicle must achieve a fuel efficiency of 17 KM per litre.
6. In case of absence of driver for whatever reason, the owner shall arrange the substitute to run the vehicle as per laws as above.
7. In case of emergency, the driver will have to report for duty as per the requirement of hirer. No extra payment shall be demanded.
8. The vehicle should be regularly serviced and maintained to avoid any breakdown. In case of breakdown for reasons whatsoever, the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle / bidder. If the owner failed to arrange/replace alternative arrangement will be made by the client and the expenditure will have to borne by the owner of the vehicle. If he/she fails to pay the expenditure so incurred the same will deducted from the bill of the owner. In addition, GPS tracking device along with it software will installed in the vehicle.
9. In case of the vehicle do not report regularly, the authority will be at liberty to reject the agreement and may engage vehicle from other source.
10. Monthly hire charges and reimbursements towards cost of petrol (as per actual) (as per Govt. norms) of selected bidder will be paid in every succeeding month, as far as possible with fifteen days of the submission of bills by the service provider/ individual and no advance payment will be made.
11. The vehicles shall not be more than 3 years old from the initial registration and in good running condition during the period of contract.

12. If the services are found to be unsatisfactory, the client shall give one month notice and terminate the agreement.
13. The details of the make and year of manufacture of the vehicle, registration no., mileage (Km covered per litre) and name of the driver with Driving License No. and period of the validity etc. should be specifically provided in the general bid information sheet of the vehicle (provided with the application form) to be furnished with the Quotation **(Annexure – B)**
14. The Quotation completed in all respect should reach the undersigned on or before 4.00 P.M. dated 19.01.2026 and shall be opened on **20.01.2026 at 4.00 PM** in the presence of the bidders or their authorized representatives. There will be no bar in the opening of the sealed quotations, if the bidder or their authorized representatives remain absent. The authorized representatives must have to produce the original copy of the authorization letter (signed by the bidder) along with a copy of Aadhar / Voter ID/ DL as proof of identity or else he/she will not be allowed to remain present.
15. In case the Service Provider intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to furnish one month notice before such withdrawal of service and termination of agreement.
16. Non-submission of any of the required documents or information will subject to rejection of the application/ bid.
17. The bid/ quotation received after due date and time will not be entertained.
18. If the bidder violates any of the terms of contract, Government shall forfeit the entire amount of security deposit.
19. The undersigned reserves the right to cancel/reject any/ all the quotations without assigning any reasons thereof.
20. Selected bidder must sign an agreement in Terms & Conditions mentioned with the District Labour Officer, Kalahandi, Bhawanipatna. For engagement of vehicle on hire basis.
