The Executive Officer NAC Junagarh on behalf of Government of Odisha, invites Percentage Rate composite bids for the construction of works detailed in the table below in Single cover system ONLINE MODE from the Class of Contractors mentioned in column-5 registered with the State Governments and Contractors of Equivalent Grade / Class Registered with Central Government / MES / Railways License for execution of Construction works. The proof of registration from the appropriate authority shall be enclosed along with the Bid. If successful, the bidder who has not registered under the state Government has to register under the appropriate registering authority of state Government of Odisha in appropriate class for eligibility before signing of the agreement.

4. The Bid documents will be available in the website [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in). From 10:00 hours of 25.02.2026 to 17:00 hour of 07.03.2026 for online bidding.

5. The Bidder should have valid registration certificate with CDMS Registration and must possess *Compatible Digital Signature Certificate (DSC) of Class II or Class-III*.

6. Bids shall be received only "online" on or before 17:00 hour of 07.03.2026.

7. The Bid shall be opened at 11:00 Hours on 09.03.2026 in the office of the Executive Officer NAC Junagarh in the presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after login to the website through their DSC. If it happens to be a holiday the same will be opened in the next working days at the same time and venue.

8. The bidders shall transfer online the cost of 5 bid documents (non-refundable) EMD/Bid security as

mentioned in the above table which shall be paid electronically through the payment gateway of SBI/ICICI/HDFC as per W.D.O.M.No.6785 dated 09.05.2017 read with W.D.O.M.No.17254 dated 05.12.2017.

10. The SC/ST bidder who is willing to take the benefit of 10% grace, shall have to furnish the APS accordingly to avail the 10% grace over his bid price/quoted rates. Otherwise he will not be eligible to claim the benefit of 10% grace.

11. An affidavit towards authenticity of documents must be attached with the bid documents.

12. Labour cess in accordance with Building & Other Construction Workers' Welfare act @ 1% will be deducted from the Contractor's bill.

13. The following machineries must be used by the bidder at the time of execution of work, as directed by Engineer-in-charge / Authority.

14. The work should be completed in scheduled period.

15. If any intending bidders wish to withdraw from participation in the bid. He/she can freely withdraw from the participation before schedule date and time of closure. In case the 1<sup>st</sup> lowest bidder or even the next lower bidder withdraw in series one by one in later stage thereby facilitating a particular bidder for award then that shall be penalized with adequate disincentives with forfeiting of EMD/Bid security unless adequate justification for such back out is furnished, Appropriate action for blacklisting the bidder shall also be taken apart from dis-incentivizing the bidder.

16. If any bidder desires to avail any facility as per certain circular / order of Government has to apply for the same in writing along with the bid document. Claim at the time of opening of tender or later stage will

not be entertained.

17. The work must cover concurrent one year of defect liability period and maintenance period of the work. In addition to that 5 % Security deposit (2 % towards initial security deposit at the time of signing of the agreement + 3% Security deposit to be deducted from running or final bill amount to cover the maintenance period of the work, which shall be released to the Executing Agency after one year and the Audit on this work complete. In case, the Executing Agency fails to maintain the work during the above mentioned period, the ULB shall incur expenditure and maintain the road at the cost and risk of the Executing Agency and the entire expenditure so incurred by the ULB shall be recovered from the 5% security deposit available with the ULB, apart from blacklisting of the contractor.

18. The work should be executed following standard PWD Specification and IS Code.

19. Other details can be seen in the bidding document.

20. The authority reserves the right to cancel any or all bids without assigning any reason thereof.




