
QUOTATION CALL NOTICE

Firms/Co-operative Societies for supply of Fire safety equipment (Sand bucket, Water Bucket and fire blanket) mentioned below for 156 nos of AWCs of this Project for the year 2025-26 with following term and conditions. Quotation paper will be submitted on or before Dt **30.03.2026** up to **5 PM** and the same quotation will be opened on Dt **31.03.2026** at 11.30 AM in the Office chamber of the CDPO, Narla. The quotationers are further following requested to remain present either in person or through their authorized representative at the time of opening.

TERMS AND CONDITIONS:

1. The quotations in sealed packets during office hours i.e from **23.03.2026 to 30.03.2026**(10 AM to 5 PM) and the same will be opened **on 31.03.2026 at 11.30** AM in the office chamber of CDPO, Narla in the presence of the members of tender committee and the quotationers or their authorized agents.
2. No quotation will be entertained after the stipulated date and time.
3. Quotationers have to submit the following documents at the time of submission of quotation paper in sealed cover without which shall be rejected. Telegraphic quotation and conditioner quotation will not be accepted.
 - A. The firm must have self-attested copy of the PAN Card
 - B. GST Registration Certificate
 - C. Self attested copy of the Income tax return (Assessment) for the year 2025-26.
4. The quotation will be examined and finalized by the committee after production of sample of each item.
5. The rate quoted should be inclusive of all taxes including transporting charges and delivery of the materials to the respective AWCs under ICDS Project, Narla.
6. The successful quotationers shall supply all the articles within 7 (seven) days from the date of receipt of the supply order.

7. Payment will be made after receipt of all items physically as per supply order in the approved rate or else the order will be cancelled.
8. Non-fulfillment of the aforesaid terms and conditions will lead to non-acceptance of quotation.
9. The quotationers are required to submit the copy of the 1st page of Bank Account.

11. Lowest bidder cannot be claimed to supply the articles. Articles will be supplied as per sample approved by Committee and available of funds.




