- 1 The quotations in sealed packets during office hours i.e from 01.04.2026 to 15.04.2026 (10 AM to 5 PM) and the same will be opened on 16.04.2026 at 11.30 am in the office chamber of CDPO, Golamunda in the presence of the members of Local Purchase Committee committee and the quotationers or their authorized agents.
- 2 No quotation will be entertained after the stipulated date and time.
- 3 Quotationers have to submit the following documents at the time of submission of quotation paper in sealed cover without which shall be rejected.
Telegraphic quotation and conditioner quotation will not be accepted.
A. Self attested copy of the PAN Card
B. GST Registration Certificate
C. Self attested copy of the Income tax return (Assessment) for the year 2025-26.
- 4 The quotation will be examined and finalized by the committee after production of sample of each item by the quotationer on date 16.04.2026 .
- 5 The rate quoted should be inclusive of all taxes including transporting charges and delivery of the materials to the respective AWCs under ICDS Project, Golamunda.

- 6 The successful quotationers shall supply all the articles within 7 (seven) days from the date of receipt of the supply order.
- 7 Payment will be made after receipt of all items as per supply order in the approved rate order will be cancelled and simultaneously the security money will be forfeited, and quantity (with photo copy of banner of respective AWCs) on proper verification by the undersigned. No interest can be charged by the quotationers for deferred payment, if any.
