1. BACKGROUND

The District Administration, Kalahandi proposes to modernise **20 (Twenty) Anganwadi Centres (AWCs) into AI-Powered Smart Anganwadi Centres under the Aspirational District Programme (ADP), NITI Aayog.**

The project envisages the deployment of **AI-enabled Early Childhood Care and Education (ECCE) systems**, integrated with nutrition monitoring, to improve learning outcomes, school readiness, and service delivery efficiency at the Anganwadi level.

Accordingly, sealed proposals are invited from **eligible, reputed manufacturers / authorised dealers / system integrators for end-to-end implementation** of AI-Powered Smart Anganwadi Centres in Kalahandi District.

2. OBJECTIVES OF THE PROJECT

- Improve foundational literacy, numeracy, and cognitive skills of children aged 3-5 years.
- Enable adaptive, personalized learning using AI-based tools.
- Strengthen convergence between nutrition and learning outcomes.
- Reduce administrative burden on Anganwadi Workers through dashboards and automation.
- Institutionalize data-driven governance in ICDS.

3. SCOPE OF WORK


The selected bidder shall be responsible for **supply, installation, commissioning, connectivity, training, software deployment, technical support, and maintenance for 20 Anganwadi Centres**, as detailed below.

4. DETAILED SCOPE OF SERVICES

4.1 HARDWARE & PHYSICAL INFRASTRUCTURE (PER AWC)

The bidder shall supply, install, and commission the following:

1. Interactive Smart Panel (55-65 inch, touch-enabled, HDMI/USB, in-built audio)

7. Power Backup System (minimum 1 KVA UPS/Inverter with battery)

10. ECCE Learning Kits (toys, puzzles, blocks, flashcards, storybooks)

9. Installation Accessories (mounts, cabling, signage, minor electrical fittings limited to equipment installation).

4.2 CONNECTIVITY & INTERNET SERVICES (MANDATORY)

The bidder shall be responsible for end-to-end internet connectivity at each AWC, including:

- Provisioning and activation of SIM cards/data plans
- Internet connectivity sufficient for AI modules, dashboards, and data synchronisation
- Maintenance and replacement of faulty SIMs or connectivity hardware
- Ensuring minimum 95% uptime per month

4.3 AI SOFTWARE MODULE – FUNCTIONAL SCOPE (MANDATORY)

The AI software deployed under this project shall include the following minimum functionalities:

A. Adaptive Learning Engine

- Real-time assessment of child responses
- Automatic adjustment of content difficulty
- Individualized learning pathways
- Coverage of language, numeracy, cognitive and socio-emotional domains

B. Child Profiling & Progress Tracking

- Unique learning profile for each child
- Longitudinal tracking of progress
- Peer and age-group comparison analytics

C. AI-Assisted Dashboards

- Colour-coded indicators (Green / Yellow / Red)
- Suggested targeted interventions for AWWs

- Mapping learning outcomes with nutrition indicators
- Predict whether the child is probable to fall into MAM/SAM category in advance (preferably 30 days) for all children of AWC
- Data from Attendance, POSHAN, test results after VR Content
- Identification of children at combined learning-nutrition risk
- Flagging for counselling and referral through ICDS/Health systems

E. Offline-First Architecture

- Core learning and data capture to function offline
- Periodic data synchronisation when connectivity is available

F. Language & Localisation

- Odia language interface (mandatory)
- Tribal language support (desirable)
- Age-appropriate, culturally contextualized content

G. Conversion of Arunima Booklet into VR content

- Convert the Concepts/Chapters of Arunima into VR Content in Odia and frame questions from the same for cognitive evaluation.

4.4 SOFTWARE CUSTOMISATION, UPDATES & CONTINUOUS IMPROVEMENT

1. The AI software, dashboards, and interfaces shall be treated as dynamic systems.
2. The bidder shall provide continuous software updates and improvements during the contract period.
3. The bidder shall carry out customisation and functional tweaks based on requirements communicated by:

- District Administration
- ICDS authorities
- Anganwadi Workers and Supervisors

4. Such customisations may include:

- Dashboard layouts and indicators
- Reports and analytics
- Content sequencing and difficulty calibration
- Language/interface refinements
- Addition or modification of data fields


5. All reasonable software modifications shall be provided at no additional cost for a period of two (2) year from date of final deployment.

4.5 TRAINING & CAPACITY BUILDING (SUPPORT COMPONENT)

- Initial hands-on training for Anganwadi Workers and Helpers
- One refresher training for all Anganwadi Workers once in 3 months for the contract period
- Training manuals and guides in Odia

4.6 ON-SITE TECHNICAL SUPPORT & HANDHOLDING (MANDATORY)

1. The bidder shall deploy at least one full-time qualified technical support personnel at Kalahandi District Headquarters.
2. The on-site technical personnel shall be deployed for a minimum period of one (1) year from the date of first deployment.

4.7 SOFTWARE SUPPORT & MAINTENANCE PERIOD


• Software support, updates, bug fixes and system stabilisation shall be provided on-call and as-required for a minimum period of TWO (2) year from final deployment.

- Software patches and upgrades
- Security updates
- Performance optimization.


