PUBLIC PROCLAMATION

(Issued under Section 503 & 504 of the Bharatiya Nagarik Suraksha Sanhita read with section 25/26 of the Police Act, 1861)

WHEREAS, the Inspector-In-Charge of **Town PS, Bhawanipatna / M.Rampur PS / Kesinga PS / Sadar PS, Bhawanipatna** has reported that the vehicle/property detailed in the schedule below has been found abandoned / seized within their Police Station Jurisdiction under suspicious circumstances / as unclaimed property, and is currently lying in the custody of the police.


AND WHEREAS, the owner or the rightful claimant or financiers of the said vehicle/property has failed to establish their claim till date or has not been traced by the police after diligent local enquiry.

THEREFORE, NOTICE IS HEREBY GIVEN to the general public that any person having any lawful claim, title, or interest in the vehicle/property described below must appear in person or through an authorized legal representative before the Court of the Sub-Divisional Magistrate, Bhawanipatna and file a formal application with valid legal document (Registration Certificate Purchase Invoice Insurance policies or court order) to establish their ownership within **six (6) months** from the date of publication of this proclamation.

TAKE NOTICE that, if no valid claim or objection is received within the specified period of six months, the vehicle/property shall be deemed as State Government property and will be disposed of via Public Auction and the sale proceeds will be credited to the government treasury. No further claims, applications, or objection will be entertained after the expiry of the deadline, and the sale proceed shall be forfeited to the state Government.
